

## **Badger Invite- August 20<sup>th</sup> and 21<sup>st</sup>**

### **Teams:**

### **Format:**

6 dual match tournament. 3 matches Friday and 3 matches Saturday.  
4 teams will report to each site. Each dual match will get 4 courts for their match.  
First two matches will be at the same site. Between the 2<sup>nd</sup> and 3<sup>rd</sup> match each day two teams from each site will travel

### **Tournament Scoring:**

Team format for scoring: 4 singles and 3 doubles. Feel free to bring an exhibition doubles to play if time allows or extra players to change your line-ups between each match.

Match scoring is best two out of 3 sets with a match tiebreak for the 3<sup>rd</sup> set.

The team with the best record at the end of the tournament will be the tournament champions. If there is a tie the winner will be determined by head-to-head results.

- If two teams who have NOT played each other have the same record, the tiebreaker will be least games lost throughout the tournament

The top two teams in the tournament will receive medals for their players.

### **Important Notes:**

Please bring enough tennis balls to cover half of each dual match.

Both days the first matches will begin at 8:30am at each site. Match play will be continuous. At the end of your first dual, if your next opponent's players are ready and there are courts available, send them out to start their match.

The winning team for each dual is responsible for putting the scores into TennisReporting.
