Waiver of Liability and Hold Harmless Agreement & Consent for Treatment Medical Authorization

NAME OF PROGRAM: Badger Baseball

COVID-19 WAIVER:

By registering for this Badger Community Education program, you are acknowledging that an inherent risk of exposure to COVID-19 exists in any public place where people are present. By attending program, you and any guests voluntarily assume all risks related to exposure to COVID-19 and agree not to hold Badger Community Education, Lake Geneva Schools, subcontractors/teachers, or any of their affiliates, directors, officers, employees, agents, contractors, or volunteers liable for any illness or injury.

CONSENT FOR TREATMENT/MEDICAL AUTHORIZATION:

I am the parent, or legal guardian of the player listed in section 1 above. In consideration for my child being registered for this program, I do hereby agree to indemnify and hold harmless any and all claims or expenses, including all medical or legal expenses, against Badger Community Education, its officers, directors, coaches, agents, employees of, or Badger High School, its officers, directors, coaches, agents, or employees of from all liability for negligence causing any injuries or damages to me or my child, as a result of her participation in the Badger Community Education Jr. Badgers Program (including any injuries or damages arising from tournaments, games, or practices). I understand that there are risks involved in basketball, which is a contact sport, and that my child may sustain injury while participating. I hereby declare that the information I have provided above is true and accurate to the best of my knowledge. I have disclosed any or all medical or physical conditions, which would affect my child's ability to participate in basketball. I do hereby authorize Badger Community Education Jr. Badger's Program and/or its coaches to secure emergency care, if necessary, for my child. I understand this agreement is binding on me, my child, my heirs, and assigns, to the extent permitted by law.

WAIVER:

1. In consideration for receiving permission to participate in Badger Community Education, I hereby **release, waive, discharge and covenant not to sue** the Lake Geneva-Genoa City Union High School District, its officers, agents, servants, or employees (hereinafter referred to as **releasees**) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or my minor son/daughter, or any of the property belonging to me, **whether caused by the negligence of the releasees**, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.
2. I am fully aware of the risks involved and hazards connected with Badger Baseball and I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. **I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death**, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such an activity, **whether caused by the negligence of releasees or otherwise.**
3. I further hereby **agree to indemnify and hold harmless** the **releasees** from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, **whether caused by negligence of releasees** or otherwise.
4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a **release, waiver, discharge and covenant not to sue** the above-named **releasees**. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Wisconsin.
5. **In signing this release, I acknowledge and represent that** I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this release for full, adequate and complete consideration fully intending to be bound by same.
